PPCA & Australia Council Announce New Round Of Australia Council for the Arts Recording Grants

Following a successful fourth round, PPCA is delighted to again partner with the Australia Council for the Arts and offer another series of \$15,000 grants to assist Australian artists with new sound recordings.

2017 recipients included Sydney singer-songwriter Katie Wighton of All Our Exes Live in Texas, Indigenous Australian and Tongan singer David Leha aka Radical Son, Perth avant-electronic artist Laura Jane Lowther aka KUCKA, Chris Read and the Western Australia-Wingellina based Irrunytju Band and Melbourne songwriter/ musician Ella Thompson.

It's distribution time!

At this time of year the PPCA Distribution team is working harder than ever, to get your annual distributions to you before the end of the year. By the 31st of December we will be distributing around \$43M to PPCA Licensor Labels and Registered Artists, for the year ending June 2017.

It seemed a good time to remind you what is and isn't included in the PPCA distribution. As you will all know PPCA operates on a non-exclusive basis, which means that users of recordings are free to approach rights owners directly for licences if they prefer, rather than taking advantage of the blanket PPCA licence offerings. Note that, at present, neither commercial or subscription television broadcasters have broadcast licences in place with PPCA for music video clips. Currently the distributions covering music videos are predominantly for the ABC (which does have a video clip broadcast licence with PPCA) and for the many commercial venues that have licences for the music video clips they exhibit on their premises (for example, from video jukeboxes).

Similarly on-demand streaming services (such as Spotify and Apple Music) are not licensed by PPCA, and nor are download services such as iTunes or BigPond. Licence fees for some customised streaming services (as opposed to on-demand) such as Pandora are included in this distribution, but please note that arrangements with Pandora concluded as at 30 June 2016. This year the distribution includes, for the first time, net revenues resulting from the Commercial Radio Simulcast Licence Scheme, which was introduced in the 2016/17 period, and also resulted in some back payments for previous periods, which are also incorporated into this year's overall distribution.

PPCA is delighted to once again be passing significant sums back to our Licensors and Registered Artists. We hope our hard work will lead to even larger distribution payments in the future.

2017 Australian Music Prize

PPCA is pleased to announce that its long-running sponsorship of The Australian Music Prize (AMP) will continue when the award returns in 2017. Set to mark its thirteenth year, The AMP aims to encourage excellence in Australian music by awarding a \$30,000 prize (supplied by PPCA) to an artist who a panel of music industry judges vote as having the best contemporary release of the calendar year.

Previous winners of The AMP have included Courtney Barnett, Remi, Big Scary, The Drones, Lisa Mitchell, Cloud Control and A. B. Original.

The National Hotel in Melbourne played host to a free open to the public event on 5 December where the 13th AMP Longlist was revealed. After listening to more than 400 Australian albums – a record – released in the 2017 calendar year, the expert team of AMP judges, led by Chairperson Dave Faulkner, have confirmed the following 46 albums have made the Longlist:
