Effective Date	This Tariff applies from 1 July 2017															
What is licensed under this Tariff?	Protected sound recordings															
What uses are covered by this Tariff?	<p>This Tariff covers the playing of protected sound recordings:</p> <p>(a) at any ticketed multi-act music event (or part thereof), where a sound recording is used in any form,</p> <p>(b) between acts at a multi-act music event, or</p> <p>(c) at a not-for-profit event solely for under age participants.</p> <p>This Tariff <u>does not</u> cover the playing of sound recordings as licensed under:</p> <ul style="list-style-type: none"> <li>▪ Tariff E1 (Nightclubs),</li> <li>▪ Tariff E2 (Dances and Dance Parties).</li> </ul>															
What are the Licence Fees?	<p>(a) The following table sets out the Licence Fees payable according to the percentage of time acts utilising sound recordings perform throughout the multi-act music event. The fees are applied per person, per event, based on the number of attendees. A separate Licence Fee is payable for each performance area where sound recordings are played.</p> <p>Where the stage or performance area includes acts or attractions before or after the ‘main act or acts’ (determined by such factors as event description, headline billing, advertising weighting, similarity to other events, or other factors as is appropriate), the applicable percentage will be the greater of:</p> <ul style="list-style-type: none"> <li>▪ the percentage of sound recording use during the main act or acts, and</li> <li>▪ the percentage of sound recording use across all of the acts at that stage or performance area.</li> </ul> <p>The percentage of time calculation excludes sound recording use between acts as described in (b) overleaf. Licence Period	Per Event
Special conditions applicable to this Tariff	<p>Where any Licence Fees are calculated on the basis of the estimated attendance for an event, you must notify PPCA in writing of the <u>actual</u> attendance within 10 days after the event. If the actual attendance is higher or lower than the estimated attendance, PPCA may adjust your Licence Fees accordingly.</p> <p>You must contact PPCA to discuss your event prior to completing and submitting your application, so that we can determine the most appropriate licence. PPCA will generally increase Licence Fees with effect from 1 July of each year, in line with the movement in the Consumer Price Index (CPI) since the date of the last increase or review. CPI increases will not be notified to Licensees separately, but will be applied to all invoices issued on or after 1 July in each year. Any increase in Licence Fees as a result of a broad or structural review of a Tariff will only be implemented following a period of consultation with the affected industry sector.
