Effective Date	This Tariff applies from 1 July 2018
What is licensed under this Tariff?	Protected sound recordings
What uses are covered by this Tariff?	<p>This Tariff covers the playing of protected sound recordings as a general amenity, or as background music, for the entertainment of customers, patrons and other attendees at commercial or professional premises, including:</p> <ul style="list-style-type: none"> (a) art galleries, libraries, zoos and museums; (b) bars, function rooms, hotels and motels, clubs and taverns; (c) elevators, corridors, foyers, lounges, reception areas, and other common areas; (d) funeral parlours; (e) hairdressers, beauty salons / spas, nail bars; (f) health/medical offices (e.g. doctors, dentists, chiropractors, massage therapists, osteopaths and physiotherapists); (g) retail stores (including for demonstration purposes in electrical, video / DVD rental and hi-fi stores, and the electrical / home entertainment sections of department stores and other retail premises); <p>and similar establishments.</p> <p>This Tariff <u>does not</u> cover the playing of protected sound recordings:</p> <ul style="list-style-type: none"> ▪ at Nightclubs (as defined in Tariff E1), Dances or Dance Parties (as defined in Tariff E2); ▪ as a predominant means of entertaining patrons in a bar or similar venue (covered by Tariff E3); ▪ through jukeboxes (covered by Tariff J); ▪ in restaurants (covered by Tariffs R1 and R2); or ▪ where venue is used for Music Events and Festivals (Tariff E4). <p>This Tariff also does not cover the public exhibition of music videos.</p>

What are the Licence Fees?	<p>The Licence Fees are calculated on the basis of the size of each area in which protected sound recordings are played, as specified in the following table:</p> <table border="1" data-bbox="480 383 1430 685"> <thead> <tr> <th>Category</th> <th>Size of each area in which sound recordings are played</th> <th>Licence Fee</th> </tr> </thead> <tbody> <tr> <td>M1</td> <td>Up to 140 m² (approx 1,500 ft²)</td> <td>\$80.63</td> </tr> <tr> <td>M2</td> <td>141 m² to 465 m² (approx 1,501 ft² - 5,000 ft²)</td> <td>\$108.67</td> </tr> <tr> <td>M3</td> <td>466m² to 930m² (approx 5,001 ft² – 10,000 ft²)</td> <td>\$148.05</td> </tr> <tr> <td>M4</td> <td>over 930 m² (approx 10,000 ft²)</td> <td>\$187.19</td> </tr> </tbody> </table> <p>Note that a separate Licence Fee is payable for each room, level or other area where protected sound recordings are played. If a venue has more than one room, level or other area, then each of those areas incurs a separate Licence Fee calculated at the rate specified in the table.</p> <p><u>Example:</u> A Hotel with a 40m² gaming area, a 150m² lounge bar and 120m² beer garden: The Licence Fee will be calculated as follows: M1 at \$80.63 for the Gaming area (40m²); M2 at \$108.67 for the Lounge bar (150m²) and M1 at \$80.63 for the Beer Garden (120m²) = Total \$269.93.</p>	Category	Size of each area in which sound recordings are played	Licence Fee	M1	Up to 140 m ² (approx 1,500 ft ²)	\$80.63	M2	141 m ² to 465 m ² (approx 1,501 ft ² - 5,000 ft ²)	\$108.67	M3	466m ² to 930m ² (approx 5,001 ft ² – 10,000 ft ²)	\$148.05	M4	over 930 m ² (approx 10,000 ft ²)	\$187.19

ALL LICENCE FEES UNDER THIS TARIFF ARE PAYABLE IN FULL, ANNUALLY IN ADVANCE. ALL AMOUNTS ARE INCLUSIVE OF GST.

PPCA will generally increase Licence Fees with effect from 1 July of each year, in line with the movement in the Consumer Price Index (CPI) since the date of the last increase or review. CPI increases will not be notified to Licensees separately, but will be applied to all invoices issued on or after 1 July in each year. Any increase in Licence Fees as a result of a broad or structural review of a Tariff will only be implemented following a period of consultation with the affected industry sector.
