Effective Date	This Tariff applies from 1 July 2018																																											
What is licensed under this Tariff?	Protected sound recordings																																											
What uses are covered by this Tariff?	<p>This Tariff covers the playing of protected sound recordings as background musical entertainment:</p> <p>(a) during the assembly and dispersal of spectators or other attendees, and during intervals between play or events, at sports arenas (including athletics, basketball, boxing, cricket, football, polo, tennis and wrestling);</p> <p>(b) during the assembly and dispersal of spectators or other attendees, and during intervals between events, at race tracks, showgrounds, speedways and similar venues; and</p> <p>(c) at outdoor amusement parks.</p> <p>This Tariff <b>does not</b> cover any featured use of protected sound recordings, or the playing of protected sound recordings as part of any "extra" performances or events outside of the uses described above (e.g. festivals or concerts, which are covered by Tariffs B and X respectively).</p> <p>This Tariff also does not cover:</p> <ul style="list-style-type: none"> <li>▪ the playing of protected sound recordings at Dances or Dance Parties (as defined in Tariff E2);</li> <li>▪ the playing of protected sound recordings as background music in bar areas (covered by Tariff M) or restaurants (covered by Tariff R1); or</li> <li>▪ the playing of protected sound recordings at Music Events and Festivals (Tariff E4).</li> </ul>

PPCA will generally increase Licence Fees with effect from 1 July of each year, in line with the movement in the Consumer Price Index (CPI) since the date of the last increase or review. CPI increases will not be notified to Licensees separately, but will be applied to all invoices issued on or after 1 July in each year. Any increase in Licence Fees as a result of a broad or structural review of a Tariff will only be implemented following a period of consultation with the affected industry sector.
