What is licensed under this Tariff?	Music videos																				
What uses are covered by this Tariff?	<p>This Tariff covers the public exhibition of music videos at premises/venues owned, occupied and/or operated by the licence holder.</p> <p>This Tariff <u>does not</u> cover:</p> <ul style="list-style-type: none"> ▪ the public exhibition of music videos in a Nightclub (covered by Tariff WE); ▪ the public exhibition of music videos in public vehicles (covered by Tariff WP); ▪ the public exhibition of music videos in retail premises (covered by Tariff WR); or ▪ the playing of protected sound recordings, where the source is other than the music video soundtrack. 																				
What are the Licence Fees?	<p>(a) Where a <u>single screen</u> is used in a room/viewing area to display the music videos, the Licence Fees are calculated on the basis of the size of the screen, as specified in the following table:</p> <table border="1" data-bbox="517 943 1501 1133"> <thead> <tr> <th>Screen size</th> <th>Annual fee</th> </tr> </thead> <tbody> <tr> <td>Small (up to 75 cm)</td> <td>\$622.60</td> </tr> <tr> <td>Large (76 - 250 cm)</td> <td>\$1,245.53</td> </tr> <tr> <td>Extra large (over 250 cm)</td> <td>Price on application</td> </tr> </tbody> </table> <p>(b) Where <u>multiple screens</u> (i.e. two (2) or more) are used in a room/viewing area to display the music videos, the Licence Fees are calculated on the basis of both the size and number of screens in each room/viewing area, as specified in the following table:</p> <table border="1" data-bbox="517 1249 1501 1469"> <thead> <tr> <th>Screen size</th> <th>Fee for the first two (2) screens</th> <th>Fee for the third (3rd) and each additional screen</th> </tr> </thead> <tbody> <tr> <td>Small (up to 75 cm)</td> <td>\$933.90</td> <td>\$155.21</td> </tr> <tr> <td>Large (76 - 250 cm)</td> <td>\$1,868.68</td> <td>\$311.08</td> </tr> <tr> <td>Extra large (over 250 cm)</td> <td>Price on application</td> <td>Price on application</td> </tr> </tbody> </table> <p>(c) Where <u>video jukeboxes</u> are used to display the music videos, the Licence Fees are calculated on the basis of the number of screens located in each room/viewing area, as follows:</p> <ul style="list-style-type: none"> ▪ \$466.73 per annum for the first screen; ▪ \$116.38 per annum for the second and each additional screen located in the same room/viewing area of the premises/venue; and ▪ \$232.87 per annum for any additional screens located in separate rooms/viewing areas of the premises/venue. <p>Note that a separate Licence Fee is payable for each room or other viewing area where music videos are displayed. PPCA will generally increase Licence Fees with effect from 1 July of each year, in line with the movement in the Consumer Price Index (CPI) since the date of the last increase or review. CPI increases will not be notified to Licensees separately, but will be applied to all invoices issued on or after 1 July in each year. Any increase in Licence Fees as a result of a broad or structural review of a Tariff will only be implemented following a period of consultation with the affected industry sector.
