What is licensed under this Tariff?	Music videos																						
What uses are covered by this Tariff?	<p>This Tariff covers the public exhibition of music videos at premises/venues owned, occupied and/or operated by the licence holder.</p> <p>This Tariff <u>does not</u> cover:</p> <ul style="list-style-type: none"> ▪ the public exhibition of music videos in a Nightclub (covered by Tariff WE); ▪ the public exhibition of music videos in public vehicles (covered by Tariff WP); ▪ the public exhibition of music videos in retail premises (covered by Tariff WR); or ▪ the playing of protected sound recordings, where the source is other than the music video soundtrack. 																						
What are the Licence Fees?	<p>(a) Where a <u>single screen</u> is used in a room/viewing area to display the music videos, the Licence Fees are calculated on the basis of the size of the screen, as specified in the following table:</p> <table border="1" style="width: 100%; border-collapse: collapse; text-align: center;"> <thead> <tr> <th style="width: 60%;">Screen Size</th> <th style="width: 40%;">Annual fee</th> </tr> </thead> <tbody> <tr> <td>Small (up to 75 cm)</td> <td>\$715.83</td> </tr> <tr> <td>Large (76 - 250 cm)</td> <td>\$1,432.37</td> </tr> <tr> <td>Extra large (over 250 cm)</td> <td>Price on application</td> </tr> </tbody> </table> <p>(b) Where <u>multiple screens</u> (i.e. two (2) or more) are used in a room/viewing area to display the music videos, the Licence Fees are calculated on the basis of both the size and number of screens in each room/viewing area, as specified in the following table:</p> <table border="1" style="width: 100%; border-collapse: collapse; text-align: center;"> <thead> <tr> <th style="width: 30%;">Screen Size</th> <th style="width: 35%;">Fee for the first two (2) screens</th> <th style="width: 35%;">Fee for the third (3rd) and each additional screen</th> </tr> </thead> <tbody> <tr> <td>Small (up to 75 cm)</td> <td>\$1,073.98</td> <td>\$178.32</td> </tr> <tr> <td>Large (76 - 250 cm)</td> <td>\$2,149.14</td> <td>\$357.56</td> </tr> <tr> <td>Extra large (over 250 cm)</td> <td>Price on application</td> <td>Price on application</td> </tr> </tbody> </table> <p>(c) Where <u>video jukeboxes</u> are used to display the music videos, the Licence Fees are calculated on the basis of the number of screens located in each room/viewing area, as follows:</p> <ul style="list-style-type: none"> ▪ \$536.59 per annum for the first screen; ▪ \$133.68 per annum for the second and each additional screen located in the same room/viewing area of the premises/venue; and ▪ \$267.71 per annum for any additional screens located in separate rooms/viewing areas of the premises/venue. <p>Note that a separate Licence Fee is payable for each room or other viewing area where music videos are displayed. Any increase in Licence Fees as a result of a broad or structural review of a Tariff will only be implemented following a period of consultation with the affected industry sector.
