Enjoy real music in your fitness class!

Everyone knows the right type of music will put you in the right mood for exercise. This means fitness classes can play real music freely without breaching Australian copyright laws, and the licence fees go back to the artists and labels that created the music, ensuring they are rewarded for their hard work.

Spring into the Event Season!

Winter is over and as we emerge from hibernation, the planning starts for the season of dance parties, music festivals, film festivals, community gatherings and more. PPCA has a selection of tariffs tailored to fit varying uses of music to ensure you hold the right licence for your activity. In addition, the E4 Tariff makes it easier to assess what licence is required for your music event or festival.

A quick overview: The Music Events and Festivals Tariff (E4) licenses the playing of protected sound recordings in any form at a ticketed multi-act music event, including sound recordings used between live acts. Tariff B covers the playing of protected sound recordings at events such as arts, food/wine, sporting, film and community festivals, as well as eisteddfods, exhibitions, and fashion shows.

The E2 Tariff is primarily for Dance Party Events, with Tariff C being for the public exhibition of films.

Vale Gavin Jones

PPCA would like to express its sadness at the passing of Gavin Jones, founder of the Deadly Awards.

Founding his company Deadly Vibes Australia in 1993, Jones staged the first Deadly Awards in a hall in the Sydney suburb of Redfern in 1995. The event has grown considerably over the past two decades; since 2001 it has been staged annually at the Sydney Opera House and broadcast nationally on SBS. Following Jones' passing, the 2014 Deadlys were cancelled.

Jones was also instrumental in the establishment of the Deadly Vibes magazine, Deadly Sounds radio show and Vibe TV production company. He was a tenacious champion in highlighting the important contributions of Aboriginal and Torres Strait Islanders to Australian music and society.

Our sincerest condolences to the family and friends of Gavin Jones.

Tariff Highlight - Music Videos and Film

While viewing a movie, video clip or TV show, we are very obviously aware of the visual images, but often don't think about the underlying music.

Businesses are increasingly using visual media to entertain and engage patrons. If you are using music video clips in your business then you need to obtain the necessary permission (ie a licence) from the rights holders for each clip. PPCA can help you to do this easily as we are authorised to collect for the public exhibition of music video clips, and also the public performance of soundtracks contained in films.

PPCA tariffs W, WE, WP and WR cover the playing of music videos in spaces including nightclubs, public vehicles and retail premises. Tariff C covers the performance of recordings as part of the soundtrack when films are exhibited, and the playing of recordings as background music in theatres.
